Hanvon Production, in addition to manufacturing our tablet series, has gone on to produce the Business Card Master, E-phone, Hanwang OCR, Biometric Fingerprint Attendance Recording System, Vehicle License Plate Recognition System, Bank Document Recognition System, and ID Card Recognition System. Attracted to our high standards for quality and comprehensive services, Hanvon Production has become a major OEM provider for a number of leading companies throughout China, including Lenovo, Haier, Handsome, Greatwall and Tsinghua Tongfang.
