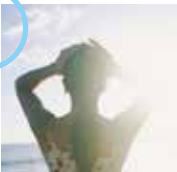

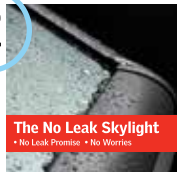

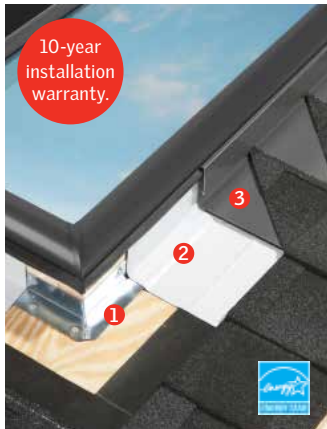


**No Leak warranty**

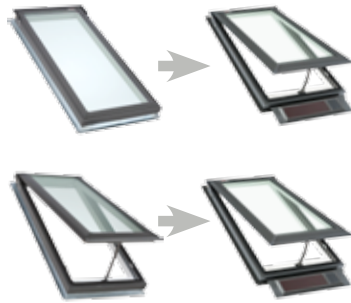


## 3 layers of water protection

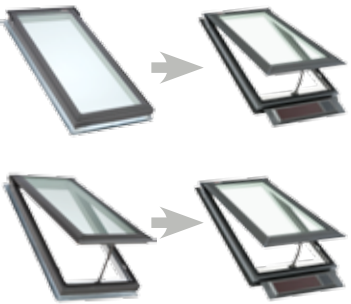


