According to <u>TSA guidelines</u>, personal repellents in liquid, gel and aerosol form are allowed in both checked bags and carry-on luggage, but may be subject to certain size and quantity restrictions.

According to the <u>Federal Aviation Association</u> most insect repellents in non-aerosol liquid pump sprays and wipes are not restricted as hazardous materials – and therefore not subject to size or quantity limits in checked luggage. Some liquid repellents are flammable -- these are still allowed but must stay within the size and quantity limits specified by the FAA. Liquids and aerosols in carry-on baggage are further limited to 3.4 oz (100 ml) containers at the TSA security checkpoint.
